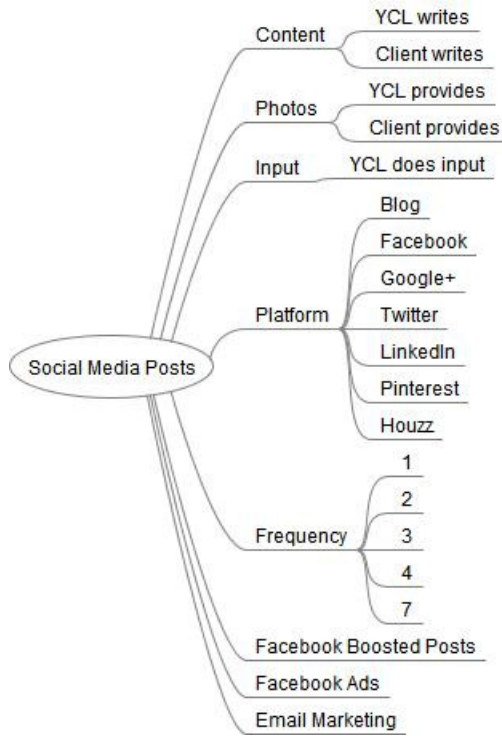

Timeline

Platform Profiles

Payment Terms
